IV. DATA PRIVACY AND PROTECTION COMPLIANCE

This documentation serves as a formal request for the necessary integrations to facilitate KYC verification processes, aligning with LTGS Plc's commitment to service excellence and regulatory compliance.

To ensure compliance with both the **National Bank of Rwanda (BNR)** and the **Rwanda Utilities Regulatory Authority (RURA)**, LTGS Plc can adopt a structured approach. Given that LTGS Plc holds a Certificate of System Registration from BNR, this sets a strong foundation for regulatory alignment.

Below are steps LTGS Plc can take to ensure ongoing compliance with both BNR, RURA and Data Protection & Privacy Office from National Cyber Security Authority (NCSA)

1. COMPLIANCE FRAMEWORK FOR DATA PROTECTION & PRIVACY OFFICE (DPO) FROM NATIONAL CYBER SECURITY AUTHORITY (NCSA).

LTGS PLC has implemented comprehensive measures to ensure the protection of personal data and privacy. We are certified as a **Data Controller** by the **Data Protection and Privacy Office (DPO)** under the **National Cyber Security Authority (NCSA)**. Our systems are designed to maintain data integrity and restrict access based on staff levels to safeguard sensitive information.

2. COMPLIANCE FRAMEWORK FOR BNR (NATIONAL BANK OF RWANDA)

Since LTGS Plc is registered with BNR, the company must follow guidelines for financial system operations, particularly for electronic transactions, customer identification, and anti-money laundering (AML) procedures.

3. COMPLIANCE FRAMEWORK FOR RWANDA UTILITIES REGULATORY AUTHORITY (RURA)

RURA oversees telecommunications and utility services, particularly where LTGS services integrate with telecom providers like MTN and Airtel for customer identification and SMS-based notifications.
